► **Deadline for CAR SHOW PRE-REGISTRATION: Septemeber 15, 2008**

Car and Truck show spaces will be for showing your classic show vehicle only. If you want to sell or promote any personal or merchandise products or services, **YOU MUST complete and submit a separate VENDOR registration.** Standard spaces will be 2 car parking lot spaces (one for your show vehicle and one for your personal space between the other vehicles). No trailers allowed in event perimeter during the event when gates are open to general public. You should plan on arriving at 8:00 am on the day of the event, Saturday, September 20th, 2008 through the dedicated Car Show entrance that will be marked. You **MUST** be in your designated show spot no later than 10AM!

If you are signed up for additional volunteer roles, or you are a participating vendor, sponsor, or a BBQ Cooking Team you may then coordinate to arrive with your show vehicle on Friday, September 19th. All car show participants must be set up **NO LATER** than 10:00 am on Saturday, so we may have everyone in place before the opening of event to the general public. All personal non-showing vehicles, trailers, etc. must be removed and out of any fenced in area and front parking lot of Grapevine Bass Pro Shop by 10:30am **NO EXCEPTION!** Park **BEHIND** Embassy Suites Outdoor World! All items must be removed from the fundraising site the evening of Sept. 20th concluding this event at 6:30pm. The event that will open for the general public is Saturday, 11am until 6:30p.m. and general admission will be **FREE**. Please plan on bringing anything that you will need with you to minimize in and out of gate traffic. When you arrive please plan to check in at the **CAR SHOW CHECK-IN BOOTH** for your assigned space. Please plan on bringing tables, chairs, tents for shade with you. These items will not be provided. You will also be responsible to clean up around your space prior to departure and during event. Space decoration and artistic presentation is strongly encouraged, and our event theme is the "Old West". **Important: NO beverage or food can be brought in. NO personal coolers allowed.** Food and Beverage booths will be available for purchase (we will be selling BBQ, beer, water, soda, hotdogs, etc.) The event will take place rain or shine. You will be provided an event schedule and all information prior to event if you have pre-registered. There is an additional event guide that will have a 15,000+ distribution, so if you are interested in advertising, go to www.campcraigallen.org under the volunteer tab to obtain the event ad contract. Reminder this is a fundraiser for this charity to raise money to build a wheelchair accessible camp, please see the website for more information.
